Present: Dale Harmon, Steve Lewis, Chuck Cunningham, Russell Pinkham and Town Manager, Dan Bryer Jr.

5:00 Early start for joint meeting with the Boothbay Harbor Select Board regarding the Boothbay Region School Charter.

Present from BH Select Board: Denise Griffin, Michael Tomko, Tricia Warren, Kenneth Rayle, Alyssa Allen. Discussion: There isn't a lot of time to put changes on the November ballot. The following basic timeline will have to be met:

The changes will have to be decided by July 1st, then it will have to go to an attorney for the wording of the referendum question. The final wording will have to be to ready for ballot printing by September 1st. With such a short timeframe, the concentration should be on the "low hanging fruit" for this voting cycle. The discussion should continue for the 2023 referendum to get into the nitty gritty of the charter.

There are a number of things that need to be changed due to the charter being simply out of date.

Top priorities at this time:

Changing the voting criteria for the school budget and school bonds to a town meeting referendum vote in hopes to give more of the taxpayers the opportunity to weigh in on the school budget and spending.

Change payment structure for towns to the school district.

The next meeting on the matter will be May 18, 2022 @ 5:00 PM.

Maine Lobsterman's Association (MLA) & Lobster 207 (Maine Lobsterman's Union) funding request:

Mark Jones and Troy Plummer representing the MLA are here to talk about the ongoing battle with the federal government regarding the unjust Right Whale regulations being mandated for Maine Fisherman. The MLA sent letters to all historic coastal lobstering communities looking for financial support for the rising legal cost of this ongoing battle. They are hoping to raise 10 million dollars over a 10 year period. If the MLA is successful in their legal fight, it will benefit all fisherman not just members of the MLA. The MLA has set up a specific fund for the legal fees.

Mark Brewer, representing Lobster 207, is also asking for financial support for Lobster 207's efforts in fighting the Federal Government and the closure of prime federal water fishing grounds.

Steve Lewis asked why they weren't working together. Mark replied that they are each coming at it from a different angle.

The board wants both organizations to know that they fully support the local fishing industry and would like to donate something. Once June comes around they will have a better idea of what they may have available to contribute. The board urges both organizations to come before them as many non-profit entities do for funding and the request can be put on the ballot at a town meeting for voters to weigh in. This way they may be able to get a larger amount of money.

The Board had some questions on the application. Brandon Moser, attorney from Perkins Thompson, is in attendance to answer questions.

Cunnigham questions the ownership, management and decision making control of the Inn. The ownership percentage is confusing that Rich and Rob each have 5% ownership yet are decision making authority over the Inn.

Mosser explains that they are the two individuals who have control. The other ownership are two entities and do not have decision making control.

Cunnigham would like an OK from the state that this type of ownership is acceptable. An email would be fine. Cunnigham then questions the Liquor License class. The application is asking for a Class V Bed and Breakfast class. The town would not consider this a bed and breakfast. It would be an Inn and should be a Class I (A) liquor license.

Mosser agreed that was a clerical error and would be amended and the additional fee paid to the State.

Mike Tomacelli made a motion to conditionally approve the Ocean Point Inn's Innkeeper's License, Special Amusement Permit (Class C) and a Liquor License (Class I (A)) with the condition the state provides an email that they are OK with the ownership hierarchy. Russell Pinkham seconded the motion. Vote: 3-0 in favor.
